POLICY DOCUMENT ON FEE CONCESSION AND SCHOLARSHIP COMMITTEE

Dyal Singh College, Karnal is a premier institution which is committed to serving the poor, needy and marginalised students. The college owes its existence to the great Founder Sardar Dyal Singh Majithia, a great philanthropist and a progressive social reformer, who donated his entire wealth to the creation of three great legacies – The Tribune Trust, Dyal Singh College, Lahore and Punjab National Bank. Following in the footsteps of our illustrious founder, the college strives to provide financial assistance and benefits to its needy students. For this purpose, a Fee Concession and Scholarship Committee has been constituted. Headed by a senior faculty member, the committee ensures timely and genuine help to the meritorious and needy students of the college.

FEE CONCESSIONS

Fee Concession and Scholarship Committee works round the year for the above mentioned purpose. At the time of admissions, fee waivers to the tune of 100%, 50%, and 25% on tuition fee are extended to the students who express their inability to pay the fee as they come from economically weaker section of society or they have no earning member in the family.

NEED-CUM-MERIT BASED SCHOLARSHIPS

Need-cum-merit based scholarships are provided to meritorious students from poor families for pursuing higher education. Every year, the committee invites applications from meritorious as well as needy students. After careful scrutiny of their forms and verification of the supporting documents, the committee members prepare a list of deserving and eligible students for the award of these scholarships.

Merit based scholarships are given to class-toppers who have maintained 75% attendance, timely submitted their assignments and done well in their sessional exams during the current sessions. Need-based-scholarships are provided to the students whose family income is low or who are fatherless or have no earning member in the family or are orphans. They too need to fulfil the condition of 75% minimum attendance besides timely submission of their assignments.

DYAL SINGH COLLEGE ALUMNI ASSOCIATION (REGD) SPONSORED SCHOLARSHIPS

The Alumni Association of the college contributes funds towards sponsorship of scholarships for meritorious students every year.

PRADHANMANTRI UCHCHTAR SHIKSHA PROTSAHAN YOJNA (PM-USP) CENTRAL SCHEME OF SCHOLARSHIPS

Under this scheme, scholarships are awarded by Ministry of Education, Government of India to the students who are above 80th percentile of successful candidates in the relevant stream from the respective Board of Examination in Class XII, (10+2), and whose family income does not exceed Rs 4.50 lakhs per annum. The college apprises the students about the PMUPS-CSSS at the time of admissions. After the verification of their documents, the eligible students receive scholarship amount of Rs 12,000/- per annum at UG level and an amount of Rs 20,000/- per annum at PG level.

Every year around fifty students are awarded this scholarship.

For renewal of this scholarship during second & third year, besides getting at least 50% marks in annual examination, maintenance of 75% attendance is mandatory.

SCHEME OF POST-MATRIC SCHOLARSHIP FOR STUDENTS BELONGING TO MINORITY COMMUNITIES

The objective of this scheme is to award scholarships to the meritorious students belonging to weaker sections of Minority Communities (Muslims, Sikhs, Christians, Buddhists, and Zoroastrians) whose family income does not exceed two lakh rupees per annum. Those students who apply for scholarships under this category on National Scholarship Portal are eligible to get a scholarship of Rs 300/- per month. A few students of the college receive these scholarships every year.
