- * Any intern found engaging in indiscipline or theft will be immediately reported to their college and will be dismissed from the company without further notice.
- * Beri Udyog Pvt Ltd will not be held responsible for any accidents or injuries incurred by interns during their training period.

- * Shall identify eligible students and provide them with the necessary information and guidance regarding the internship program.
- * Will coordinate with Beri Udyog Pvt. Ltd. to ensure a smooth transition for students during the internship period.
